# **IMMEDIATE HEALTH EFFECTS**

Eye: Not expected to cause prolonged or significant eye irritation

**Skin:** Contact with the skin is not expected to cause prolonged or significant irritation. Not expected to be harmful to internal organs if absorbed through the skin. # **SECTION 5 ACCIDENTAL RELEASE MEASURES**
